#### LET'S TALK MORE: OIL & GAS (SECOND ROUND OF SESSIONS)

Welcome to another Special Issue our "Iganiga'tunej Samqwan" Gnua'taqan, which means "Putting Our Water First".

In this second Special Issue of "Iganiga'tunej Samqwan", we once again provide the results, comments and questions from the series of Community Sessions entitled 'Let's Talk', with the subject being Hydrocarbons. The second round of sessions were held during late November and early December 2017.

In total, 85 participants joined us during these informative presentations, which also allowed for Question & Answer periods from the audience after each presentation, all of which we share in this publication.

The first presentation of the evening, was Richard Jeannotte, MMS Legal Counsel, who gave a presentation on Mi'gmaq Rights and Title. Richard spoke about the constitution of Canada and the division of powers between the federal and provincial government, Section 35 of the Constitutional Act, 1982 was explained and linked to the legal obligation of the crown to consult and accommodate Mi'gmaq rights and title. The hydrocarbons legislation drafted by Quebec was also reviewed and analyzed.

Bassem Abdradou, P.Eng. M.A.Sc, Senior Project Manager, LMG presented a reflection on the Risks of Oil and Gas production. Bassem's presentation included the different stages oil and gas goes though before it can be used and the concerns and risks associated with each step. When Bassem wasn't available at some of these sessions, Mathieu Lehoux-Gray of MMS presented on his behalf.

Scott Metallic, Field Monitor for MMS gave the last presentation; he presented a short summary of his visit to the Junex site. He informed us of the water tests near the Gault sites and the water analysis data from the observation wells that are on each site. He also showed us pictures of Junex's environmental safeguards.

The feedback from the participants were shared with the Mi'gmawei Mawiomi Leadership during thier Assembly meeting on Dec. 12 & 13th, as were the survey results. Community members can still have a voice by taking part in the surveys that are conducted in each community. See the next page for more info.

*Editors Note*: On these upcoming pages, we provide more of the comments/questions heard during the 2nd round of presentations at all 4 Community Sessions in Gesgapegiag, Gespeg, Listuguj & Montreal. The comments/questions are printed exactly as they were heard at the sessions - none were edited.

- Do you have to dig through the bedrock in order to get the oil?
- When they do their assessments do they know what's in the layers? They must know the density of the material?
- Why does the well leak? What do they mean by active wells that leak?
- If there's fracking how far is the range of impact?
- They use water to create the steam (for fracking)?
   How many gallons of water do you think they use?
- How is it that the government is allowing this type of process to go through (fracking) even though there are no studies – it says it's an environmental friendly procedure.
- Is it easy to state that these types of procedures (fracking) could put our land and water quality at risk?
- Concerns about contamination at the site. All material around the site. (Animals, Water, etc).
- An inconvenience is not enough for a "Yes" or "No" in court. Questioned about Injunctions.
- · Titles?

- Concrete actions? Mandates for negotiations. Letter from Minister Kelly. Letter says we will participate in the negotiations.
- The site you visited- where were they?
- Those are the only places they are exploring? None in Listuguj? In Gesgapegiag?
- I saw them covering up some stuff you wouldn't believe it. They bury well all that was done in the 1800's.
- Both Junex and Petrolia were working together for a while.
- Is there a way for companies to come in here without our permission?
- Why don't we just say no? That's it and that's all.
- We have fracking all over the world and we have a lot of scientific proof that it's ruining our world.
- Who says that the fracking companies will honour the [MM] resolution?
- What happens if pipelines, etc... blow up? What are the environmental impacts?

- Can you prove that if you don't have access to oil
   What activities are stopped for the 4 months? that people will die?
- Oil and gas that would be extracted from our territory it would be most beneficial for companies and not us? What are the benefits for the First Nation communities?
- It was said in the presentation that the railroad was fragile, in which way is it fragile?
- · When an occurrence happens where does the contaminated soil go?
- · Let's say they (Gespeg, Gesgapegiag) agree to oil and gas and Listugui doesn't agree? It could become a conflict.
- In regards to the Chilcotin decision the Supreme Court say that if they can justify with substantial documentation, companies could override aboriginal title and rights. Two recent cases in Ontario title rights are giving the rights to consultation and accommodation. How can communities move forward with a plan?
- · Companies Do they still have an obligation to consult with the Mi'gmag?
- · Monitoring regulations is up to the community members or MMS?

- Is it the 5 drilling sites? Until January?
- Are their any natives sitting at the board of Junex?
- What is the best course of action for insuring, implementing and putting in place a title?
- · Is it better to continue with the land claim or more important to go for a title claim?
- The blow-ups aren't as rare as everyone thinks.
- There isn't enough information coming out on oil and gas and despite the information going out, it fails to explain in the simplest terms and I [name withheld] would like to help with this.
- The presentations need to be brought down to a kindergarten level for everyone to understand.
- A Councillor [name withheld] stated that they would like to be invited to the meetings that are held with the government.
